MONTHLY TUITION FEES: PLEASE NOTE:
FULL monthly tuition is due each month regardless of the number of lessons taught in that month (can vary due to holidays, etc.) Some months have 3-4 weeks of classes, & other months have 5 weeks of classes. It evens out throughout the course of the year. **ALSO:** Students who participate in our holiday and/or annual summer recital, all of your additional rehearsals at the studio, plus the dress rehearsals & actual show days are all considered "class time" & is figured as part of the monthly tuition fee.

TUITION & REGISTRATION FEES ARE NON-REFUNDABLE, nor applicable toward any other outstanding balance that may be due on a student's account.

ANNUAL REGISTRATION FEE (per student): \$60
Each Additional Family Member: \$35

**MONTHLY CLASS FEES
PER INDIVIDUAL STUDENT:**

1 class per week (1 hr or less)	\$65/mo
1 class per week (over 1 hr)	\$85/mo
2 classes per week	\$120/mo
3 classes per week	\$160/mo
4 classes per week	\$190/mo
5 classes per week	\$225/mo
6 classes per week (unlimited)	\$240/mo

Tuition Rates are based on 45-Minute to 1-hour class time. Add \$20.00 to the above rate for any class over 1 hour long.

Form of Payment: CASH & CHECKS ARE PREFERRED
HOWEVER, DEBIT, VISA, MC ONLY ARE ACCEPTABLE

Payment Policies: Monthly Tuition Fees are due the **FIRST LESSON** of each month. Monthly bills are **NOT** sent out – we only send out "late payment" notices after the 10th of each month, which is when tuition is considered "past due". The "late fee" is \$15.00 which needs to be automatically included in your monthly payment to us any time a tuition payment is not received in our office by the 10th of any given month.

PLEASE NOTE: No refunds, transfers, or pro-rates if a student terminates in the middle of a month, or misses any classes.

Returned Checks:

\$25.00 PLUS the \$15.00 LATE FEE
Once a check is returned, CASH tuition payments will be the only acceptable form of payment each month.

MISSED CLASSES: "Make-up" lessons offered if student/parent calls in prior to or day of class time. "Make-ups" must be completed within 2 weeks of the "excused" absence or the credit for the missed class(es) is forfeited. "Make-up" lessons must be completed in a class **OTHER** than the one(s) currently enrolled in. Monthly tuition must be current before any "make-ups" are allowed. Students on "unlimited" tuition rates **DO NOT** do make-ups.

DROPPING A CLASS: If a class is dropped but the studio office has not been notified at the beginning of any given month with a written notification & a "Drop/Add" form has not been filled out & signed at the front desk, then the tuition fee is STILL DUE for that month. We encourage students to **ALWAYS COMPLETE** the month & not just "drop" a class mid-month. Also, please notify the front desk right away if there is a problem or concern, or if possibly a different class needs to be considered for the benefit of your child. Thank you.

NOTE:

STUDENTS WHO ARE COMPETITIVE COMPANY DANCERS OR PRE-COMPANY DANCERS HAVE A MONTHLY FEE THAT IS IN ADDITION TO THE MONTHLY DANCE TUITION PAYMENT. PLEASE ASK THE FRONT DESK IF YOU DO NOT REMEMBER THE AMOUNT. THANK
